 - 1. 2024-2025 OSU Board Slate

- c. Art Committee
 - i. Hijos del Sol Project Updates
 - 1. Community Mural Project
 - a. The painting of the community mural was planned to take place on Tuesday May 7th, as part of the events for Finals Week but there is a delay with Hijos Del Sol so the project may be postponed until next semester instead.
 - We don't want to rush into such an important project, so the new timeline will hopefully get the project painted during Welcome Back Week in the Fall semester.
 - b. Our goal is to have at least the sketches or initial ideas shown to the current board members before the term ends, and hopefully they can return once the projects are completed to view them in person.
 - A plaque will be placed with the mural recognizing all of the Board members who helped make this mural possible.
 - 2. Other Projects
 - a. Outdoor Stairs Mural & Indoor Stairs Decals
 - Summer Completion possibly, but the art committee is still in discussions with Hijos Del Sol at the moment.
 - ii. OSU Artist Submission
 - 1. Because of the delays in the murals being completed, we want to work to hang student art in the building in the meantime.
 - 2. Outreach will be done to those who submitted projects to the form, in collaboration with the MarComm team.

F. Additional Roles

Jeff Rensel and Diana Ballesteros Presents

- a. OSU Satisfaction Survey 2024
- b. 38 responses: 84% of respondents were students.
 - i. 53% of patrons satisfied or very satisfied with our hours of operation
 - ii. Top 3 reasons people come to the OSU: Eating, Attending an event, and to Socialize
 - iii. 57% of patrons agree or strongly agree with the statement that the OSU is the heartbeat of campus
 - iv. 73% of patrons agree or strongly agree with the statement that the OSU creates thriving student-centered spaces that support empowerments, authenticity and otter pride
 - v. 73% of patrons agree or strongly agree with the statement that they found the building to be functional
 - vi. 92% of patrons agree or strongly agree with the statement that they found the building to be comfortable
 - vii. 81% of patrons were satisfied or very satisfied with the overall cleanliness of the OSU
 - viii. 52% of patrons have read the OSU digital signage
 - ix. Top 3 types of programs patrons want to see: Arts & Crafts, Movies, and Social justice programs
- c. Feedback:
 - i. Dining comments
 - 1. Hours of operations should be extended.
 - 2. Healthier, less processed food options should be offered in the Sea Store
 - ii. More private meeting spaces for individuals are needed and more quiet spaces in the OSU.
 - 1. The OSU can work to provide more accessible quiet spaces for folks to use.
- d. Berenice Lemus is doing her Senior Capstone project on the OSU and has some feedback and suggestions as well through the research she did.
 - i. Her Capstone presentation will be held on May 16th at 1:30pm in the BIT building.
- e. Jeff Rensel is also working on other initiatives in the OSU to improve the building and bring in more engagement.
